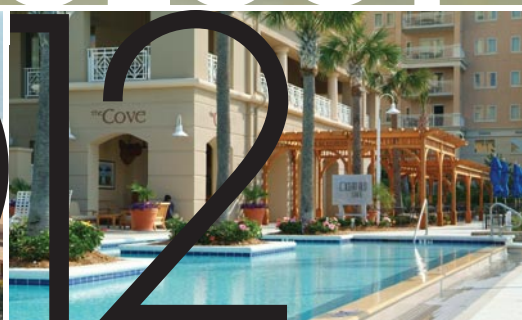

- Review current issues in professionalism and medical licensure.
